वाटर हीटर . सोलर डायर देख और जब जनक दीदी ने बताया वो अपना गैस सिलेंडर को ढाई साल बाद बदलती है और उनका जीवन और घर कचरा और कचरादान मुक्त है, हैरान हो गए । इस भ्रमणं के बाद एक बैठक हुई जिसकी शुरूआत छात्रो ने उत्साह भरे भाव प्रकट किये कि जो भी आज यहाँ देखा है इस से पहले कभी नहीं देखा।

टीआई पंकज द्विवेदी के मुताबिक घटना शुक्रवार सुबह की है। एमवाय अस्पताल से सूचना मिली थी कि 16 साल के अंकित पत्र लखन वर्मा ने अपने घर में फांसी लगाकर जान दे दी। बाद में टीम को घटनास्थल पर रवाना किया गया। अंकित न्य देवास रोड़ का रहने वाला था और नंदानगर के मैरियट स्कूल में पढ़ाई कर रहा था।

अंकित के पिता हाट बाजार में सब्जी बेचने का काम करते हैं। परिवार में दो छोटी बहन है। गुरुवार रात को अंकित ने पिता लखन को अपने हाथों से खाना लाकर दिया था। वह परिवार के लोगों से काफी देर तक बात करता रहा। बाद में वह पीछे कमरे में जाकर सो गया। पिता लखन के मुताबिक अंकित को नौंवी में भी कम मार्क्स आए थे। दसवीं की पढाई उससे ठीक से नहीं हो पा रही थी। संभवतः इसी कारण से उसने यह कदम उठा लिया। पुलिस को प्रारंभिंक जांच में ऑनलाइल गेम खेलने की लत होने की जानकारी भी मिली है। पुलिस ऑनलाइन गेम के बिंद पर धमकी मिलने, ब्लैकमेलिंग

या कर्ज को लेकर जान देने की

जांच भी कर रही है।
