

सात साल से लिव इन में रह रही महिला ने प्रॉपर्टी के लालच में मारकर फिकवा दिया था

विदिशा ,(निप्र)। पांच दिन पहले हुए अंधे कत्ल का खुलासा पुलिस ने कर दिया। जांच में पता चला है कि तोरण सिंह दांगी की हत्या प्रॉपर्टी के लालच में उसके साथ सात साल से लिव इन में रह रही 50 वर्षीय महिला ने ही की थी। महिला और हत्या में सहयोग करने वालों को गिरफ्तार कर लिया गया है। हत्या का खुलासा करते हुए विदिशा एएसपी समीर यादव और सिटी एसपी राजेश तिवारी ने बताया कि 25 अक्टूबर 2023 को रमाबाई राठौर ने अपने कुछ साथियों के साथ मिलकर बुजुर्ग तोरण सिंह दांगी की हत्या कर डाली और अपने साथियों के साथ मिलकर तोरण सिंह दांगी के शव को ज्वार के खेत में फेंक दिया था। इसके दो दिन बाद यानि 27 अक्टूबर को थाने में तोरण सिंह दांगी के लापता होने की शिकायत करने पहुंच गई। जिसके बाद 28 अक्टूबर को गांव के चौकीदार से पुलिस को सूचना मिली कि खेत पर एक बुजुर्ग

व्यक्ति की लाश मिली है। जब मौके पर शव की शिनाख्त की गई तो शव तोरण सिंह दांगी का निकाला। जिसके पुलिस ने शव को बरामद करके पोस्टमार्टम कराया। शार्ट पीएम रिपोर्ट में खुलासा हुआ कि सिर में गंभीर चोट और गला घोटने से उसकी मौत हुई है। जिसके बाद पुलिस ने मामले को गंभीरता से लेते हुए जांच पड़ताल शुरू की तो पता चला कि तोरण सिंह दांगी के साथ में रह रही महिला ने संपत्ति के लिए हत्या कर दी थी।

पता चला है कि हत्या की आरोपी रमा राठौर पिछले सात साल से मृतक तोरण सिंह दांगी के साथ रह रही थी। वह अपने आप को उसकी पत्नी बताने लगी थी। मृतक तोरण सिंह की पत्नी बेटे की पूर्व में मृत्यु हो चुकी थी। इसलिए रमा की नियत तोरन सिंह की संपत्ति पर थी जिसने अपने साथियों के साथ मिलकर तोरण सिंह दांगी की हत्या कर दी थी।
